



### **KPIG Held the Groundbreaking Ceremony for the Construction of Lido Music & Arts Center in MNC Lido City SEZ**

Jakarta – March 10, 2021. PT MNC Land Tbk (“KPIG” or “the Company”), held a groundbreaking ceremony to start the construction of Lido Music & Arts Center in MNC Lido City, Greater Jakarta. This proves KPIG's commitment to the development plan of the Special Economic Zone for Tourism (or what is often referred to as the “Tourism SEZ”) MNC Lido City. As mentioned in the previous release, MNC Lido City has obtained approval from the National Council for Special Economic Zones as Tourism SEZ.

Lido Music & Arts Center, which is wholly owned by KPIG, is built on an area of 5 ha with an amphitheater concept, making it the largest outdoor music and arts festival venue in Indonesia. It is built to accommodate more than 50,000 visitors in one event, with 4 different stages to accommodate different shows at the same time. The construction of Lido Music & Arts Center is targeted for completion by the end of 2021.

Lido Music & Arts Center will be the main destination for international music and arts festivals in Southeast Asia. Other than music and arts festivals, Lido Music & Arts Center can be utilized for other events such as sports festivals, shows and performances, cultural and

### **KPIG Gelar Acara Peletakan Batu Pertama Pembangunan Lido Music & Arts Center di KEK MNC Lido City**

Jakarta – 10 Maret 2021. PT MNC Land Tbk (“KPIG” atau “Perseroan”), mengadakan acara peletakan batu pertama untuk memulai pembangunan Lido Music & Arts Center di MNC Lido City, Jabodetabek. Hal ini membuktikan komitmen KPIG merealisasikan rencana pengembangan Kawasan Ekonomi Khusus Pariwisata (atau yang sering disebut sebagai “KEK Pariwisata”) MNC Lido City. Seperti yang diberitakan pada rilis sebelumnya, MNC Lido City telah mendapatkan persetujuan dari Dewan Nasional Kawasan Ekonomi Khusus sebagai KEK Pariwisata.

Lido Music & Arts Center, yang sepenuhnya dimiliki oleh KPIG ini dibangun di atas lahan seluas 5 ha dengan konsep amphitheater, menjadikannya tempat festival musik dan seni outdoor terbesar di Indonesia. Dibangun untuk menampung lebih dari 50.000 pengunjung dalam satu acara, venue ini memiliki 4 panggung berbeda untuk mengakomodasi pertunjukan yang berbeda pada waktu yang bersamaan. Pembangunan Lido Music & Arts Center ditargetkan selesai pada akhir tahun 2021.

Lido Music & Arts Center akan menjadi tujuan utama penyelenggaraan berbagai festival musik dan seni bertaraf internasional di Asia Tenggara. Selain festival musik dan seni, Lido Music & Arts Center dapat dimanfaatkan untuk berbagai acara lain seperti festival olahraga,

social gatherings and others. Various supporting facilities are also prepared for the convenience and comfort of the visitors, such as retail & dining, as well as various transportation accesses.

The Company observes that until now, Indonesia still does not have any outdoor facilities for world-class international music and arts festivals, to accommodate events such as the Coachella Valley Music and Arts Festival in California, America. Coachella is the largest and most famous music festival in the world, which during the show have drawn as many as 250,000 visitors from across the world.

Perseroan mengamati bahwa hingga saat ini, Indonesia masih belum memiliki fasilitas outdoor venue festival musik dan seni berkelas internasional, untuk mengakomodasi acara seperti Coachella Valley Music and Arts Festival di California, Amerika. The Company has taken advantage of this pandemic to complete a number of developments, when the conditions improve, Lido Music & Arts Center will be ready to be the first world-class outdoor music and arts festival venue in Indonesia," said Hary Tanoeoedibjo, Executive Chairman of MNC Group.

"MNC Land's Lido Music & Arts Center also supports government program for new tourist destinations, which at the same time advances the Indonesian music and arts industry," added Hary.

The groundbreaking was attended by the Minister of Tourism and Creative Economy/ Head of Tourism and Creative Economy Agency - Sandiaga Uno; Deputy Minister of Tourism and Creative Economy/ Deputy Head of Tourism and Creative Economy Agency - Angela Tanoeoedibjo; Governor of West Java, represented by the Head of West Java Tourism and Culture Agency - Dedi Taufik; Bogor Regent - Ade Yasin; Sukabumi Regent - H. Marwan Hamami; Bogor Mayor - Bima Arya; and Executive Chairman of MNC Group - Hary Tanoeoedibjo; along with the board of directors of KPIG.

After obtaining the Tourism SEZ status, the Company has accelerated the construction of MNC Lido City. Recently, in collaboration with PT MNC Studios International Tbk ("MSIN"), KPIG has already started the construction of

Wholly owned by KPIG, MNC Lido City is a 3,000 ha flagship development project as a world-class entertainment hospitality city in Greater Jakarta. MNC Lido City is surrounded by population of more than 70 million people and easily accessed with direct toll road from Jakarta. Situated between 2 picturesque mountains, it has pleasant temperature of 22-25°C all year long. MNC Lido City is the closest Tourism SEZ from Jakarta and the first in Greater Jakarta.

The MNC Lido City SEZ will become a national pride and a new tourist destination in Indonesia.
